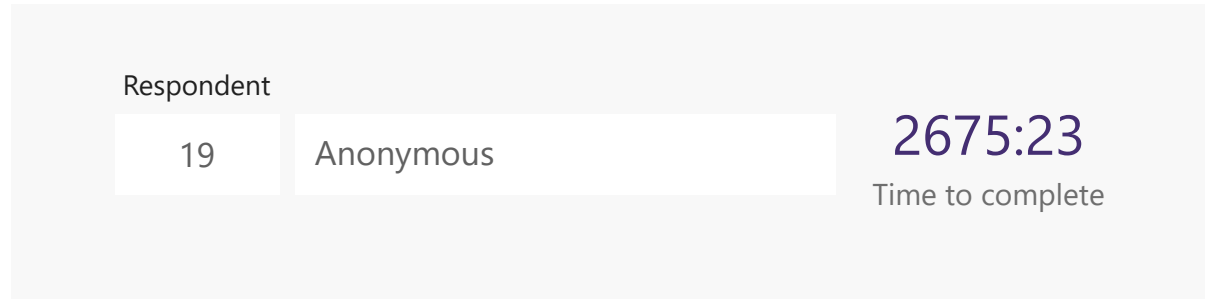


## View results



1. Do you agree with the proposed vision and goals for the action plan?

I think that the vision of the draft action is satisfactory but it could be better. I feel that it is missing actions that could be taken to protect the Tasmanian environment such as forests and oceans.

While I do agree that the 3 priority areas of the action plan are important, I think that conservation is also incredibly important and the Tasmanian Government should think about the effects of logging and how to protect our forests and oceans.

3 priority areas

-Improve information and knowledge about climate change in Tasmania

In the statement 'These resources aim to build a generation of young Tasmanians who are critical thinkers involved in exploring and understanding the science of climate change, its causes and solutions, and how society and our economy will need to build resilience and adapt to its impacts.', it sounds as if the Tasmanian Government is pushing the responsibilities of dealing with the effects of climate change onto the next generation. Climate Change is a present day issue and should be dealt with accordingly.

Providing regular updates of actions being taken, discussions being had, and new studies would help keep Tasmanians informed and understanding of updating situations. I don't know where these updates would be published but if they are easily accessible it's all fine!
